1989.05.01	The promoters' meeting was held on May 1, 1989, and the draft for the establishment of Taiwan Securities Central Depository Co., Ltd. (TSCD) was completed.
1989.09.11	Mr. See-Ming Chen was elected as Chairman and Kenneth K.S. Kao was elected as president during the third sponsors' meeting and the first board of directors meeting was held on September 11th, 1989, directors and supervisors were also appointed.
1989.10.17	The Ministry of Economic Affairs gave their approval to the establishment of TSCD on October 17, 1989.
1989.12.29	On December 29, 1989, Securities & Exchange Commission, Ministry of Finance, issued the Rules Governing Book-entry Operation of Securities in Centralized Custody and approved the Rules of Business Operation of TSCD on the next day.
1990.01.04	TSCD formally began its operations on January 4, 1990.
1990.08.30	By August 30, 1990, TSCD had successfully established the linkage among all the securities firms all over Taiwan.

2002.01.02	Starting January 2, 2002, TSCD has been providing book-entry operation of emerging stocks on clearing and delivery for cash and securities.
2005.07.29	On July 29, 2005, Financial Supervisory Commission (FSC) made the resolution on the merger of TSCD & DIDC (Debt Instruments Depository and Clearing Co., Ltd. Taiwan).
2005.09.12	Established the Offshore Fund Observation Post System (www.fundclear.com.tw) to provide information reporting and declaration as well as information transmission and cash payment services for offshore funds.
2006.03.27	On March 27, 2006, title of the organization was modified as Taiwan Depository & Clearing Corporation (TDCC) after the merger officially takes effect.
2006.11.01	Starting November 11, 2006, TDCC has been providing payment transfer operation, settlement and payment services and cross-border remittances for International Bonds.
2009.03.30	Established a shareholders electronic voting platform, the "STOCKVOTE" (www.stockvote.com.tw)

2011.07.29	As of 29 July 2011, the Taiwan Stock Exchange, the GreTai Securities Market, and the Emerging Stock Market achieved full securities dematerialization.
